THE NEED TO MODERNIZE

Courts of limited jurisdiction (CLJ) process 18 million transactions a month — approximately 87 percent of the state's caseload. They also collect the infraction revenue for the Judicial Information System (JIS) Fund, which is dedicated to the information systems that support the daily operations of all court levels. The aging CLJ case management system does not meet the needs of the courts and is in dire need of modernization.





ABOUT THE PROJECT

Court stakeholders worked together in 2014 and 2015 to identify the essential requirements for the new Courts of Limited Jurisdiction Case Management System (CLJ-CMS). Stakeholders and the Administrative Office of the Courts are now in the process of procuring a commercial off-the-shelf solution that can be configured to meet Washington courts' specific needs. Ideas, feedback, and suggestions are encouraged.

THE BENEFITS

A commercial off-the-shelf solution will meet many of the courts of limited jurisdictions' business needs out of the box. Once installed, the system will be configured to meet the unique needs of Washington courts. This approach decreases the need for costly customizations.

The goal of the new case management system is to provide improved:

- · Communication within and between courts.
- Efficiency in resource management, case docketing, scheduling, case status and progression, and party management.
- Transparency and reliability of information for judicial decision making.
- Maintenance and retrieval of court records.
- Information and access for partner agencies, attorneys, the public, and the media.
